<sup>1)</sup> Hourly rate, price per hour or part thereof. Payment shall be charged for at least one hour, and each hour commenced shall be charged as a full hour.

<sup>2)</sup> If case processing is required, an hourly rate or part thereof will be charged.

<sup>3)</sup> NB: A fee of KES 4,200/DKK 260 shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.

<sup>4)</sup> No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents – or one of these – were born Danish or have subsequently obtained Danish nationality.

<sup>5)</sup> Where several documents are issued together to the citizen, a total fee of KES 3,300/DKK 200 shall be charged.

<sup>6)</sup> Provided the request for VAT refund comprises several separate purchases, a fee of KES 3,300/DKK 200 shall be charged per statement.

<sup>7)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of KES 38,300/ DKK 2,355 shall be charged for the first passport and KES 16,500/DKK 1,010 for subsequent passports.

<sup>8)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of KES 54,800/DKK 3,365 shall be charged for the first passport and KES 16,500/KK 1,010 for subsequent passports.
