³⁾ NB: A fee of EUR 35 (DKK 260) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.

⁴⁾ No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents – or one of these – were born Danish or have subsequently obtained Danish nationality.

⁵⁾ Where several documents are issued together to the citizen, a total fee of DKK 195/KES 3000/EUR 26 shall be charged.

⁶⁾ Provided the request for VAT refund comprises several separate purchases, a fee of DKK 195/KES 3000/EUR 26 shall be charged per statement.

⁷⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 2,155/KES 30,800/EUR 288 shall be charged for the first passport and DKK 955/KES 13,700/EUR 128 for subsequent passports.

⁸⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 3,080/KES 44,000/EUR 412 shall be charged for the first passport and DKK 955/KES 13,700/EUR 128 for subsequent passports.
