⁴⁾ No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents – or one of these – were born Danish or have subsequently obtained Danish nationality.

⁵⁾ Where several documents are issued together to the citizen, a total fee of KES 3,100 / DKK 200 shall be charged.

⁶⁾ Provided the request for VAT refund comprises several separate purchases, a fee of KES 3,100 / DKK 200 shall be charged per statement.

⁷⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of KES 35,400 / DKK 2,265 shall be charged for the first passport and KES 15.100 / DKK 970 for subsequent passports.

⁸⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of KES 50,600 / DKK 3,240 shall be charged for the first passport and KES 15.100 / DKK 970 for subsequent passports.
